**Teladoc<sup>®</sup> is the first and largest provider of telehealth medical consultations in the United States, giving members anytime, anywhere access to quality medical care through phone and video consults.**

## MEDICAL CONSULTATION

### **Where is Teladoc available?**

You can get treated by a Teladoc doctor by phone or video throughout the United States. Teladoc operates subject to state regulation and may not be available in certain states.

### **When is Teladoc available?**

Teladoc phone consultations are available 24 hours a day, 7 days a week; video consultations are available 7 a.m. to 9 p.m., 7 days a week.

### **Who are the Teladoc doctors?**

Teladoc doctors are U.S. board certified in Internal Medicine, Family Practice, or Pediatrics. They average 15 years of practice experience, are licensed in your state, and incorporate Teladoc into their day-to-day practice as a way to provide people with convenient access to quality medical care.

### **Does Teladoc replace my doctor?**

No. Teladoc does not replace your family doctor or primary care physician. Teladoc should be used when you need immediate care for non-emergency medical issues. It is an affordable, convenient alternative to urgent care and ER visits.

### **How do I set up my Teladoc account?**

Setting up your account is a quick and easy process online. Visit [teladoc.com/premera](https://teladoc.com/premera) and click "Set Up Account." Follow the online instructions. You can also call Teladoc to set up an account.

#### **How do I request a consult to talk to a doctor?**

Visit [teladoc.com/premera](https://teladoc.com/premera), log in to your account and click "Request a Consult." You can also call Teladoc to request a consult by phone or mobile app.

#### **How quickly can I talk to the doctor?**

A doctor will call you back within 10 minutes, on average. If you miss the doctor's call, whether you are away from the phone or you have anonymous call blocker on, you will be returned to the bottom of the waiting list. The consult request is canceled if you miss three calls.

#### **Can I provide consult information to my regular doctor?**

Yes. You have access to your electronic medical record at any time. Download a copy online from your account or call Teladoc and ask to have your medical record mailed or faxed to you.

#### **How much will I pay for a Teladoc consult?**

You will pay your standard network office visit cost shares (copay or deductible and coinsurance).

#### **Is the consult fee the same price, regardless of the time?**

Yes! Teladoc charges one flat rate per consult based on your standard in-network office visit cost shares (copay or deductible and coinsurance).

#### **How do I pay for the consult?**

You may pay with your HSA (Health Savings Account) card, credit card, prepaid debit card, or by PayPal.

#### **Can Teladoc doctors write a prescription?**

Teladoc doctors can prescribe short-term medication for a wide range of conditions when medically appropriate. Teladoc doctors do not prescribe Drug Enforcement Agency (DEA) controlled substances, non-therapeutic drugs, and certain other drugs that may be harmful because of their potential for abuse.

#### **How do I pay for a prescription called in by Teladoc?**

When you go to your pharmacy to pick up the prescription, you may use your health/prescription insurance card to help pay for the medication. You will be responsible for the copay based on the type of medication and your plan benefits.

#### **If the Teladoc doctor recommends that I see my primary care physician or a specialist, do I still have to pay the Teladoc consult fee?**

Yes. Just like any doctor appointment, you must pay for the consulting doctor's time.



## DERMATOLOGY CONSULTATION

### **How do I access the dermatology service with Teladoc?**

Dermatology visits are available online. You can contact the Teladoc call center for assistance logging in to your account.

### **Will I be speaking with a licensed dermatology provider?**

All Teladoc dermatologists are board certified.

### **Do I need to have online access for a dermatology visit?**

Yes, you need online access for a dermatology visit. You will need to upload images and descriptions in order for a licensed dermatologist to review your photos, make a diagnosis, and provide a treatment plan.

### **Do I have to upload an image?**

In order for your dermatologist to properly review and diagnose your condition, Teladoc requires a minimum of three (3) and a maximum of five (5) images be uploaded prior to scheduling your visit.

### **What types of images are allowed?**

Acceptable image file types: JPEG, GIF, PNG at a maximum of 15MB per image.

### **Why do I have to fill out additional intake questions?**

In order to make sure our providers have the best information possible to assist members, we do require a short intake with specific questions about your dermatology concerns.

**How long will it take for the dermatologist to respond to my visit request?**

Dermatologists have up to two (2) business days to review your request and images and provide a diagnosis or ask for more information if needed.

**If my condition requires immediate attention, how will I be notified?**

Teladoc will send you information through your Message Center. To ensure your safety, and for privacy, Teladoc will also have a licensed clinician contact you by phone.

**If I am given a prescription as a result of my visit, how will I be notified?**

All diagnosis and prescription information will be managed through your Message Center.

**If the dermatologist has additional questions, how will I be notified?**

The dermatologist will send you a message through your Message Center asking for further details. You can choose how you would like to be alerted that a new message is in your Message Center (i.e. text or email).

**Can I address more than one condition when I request a visit with a dermatologist?**

Teladoc does ask that you limit request for a visit to one medical condition.

**Can I ask follow up questions?**

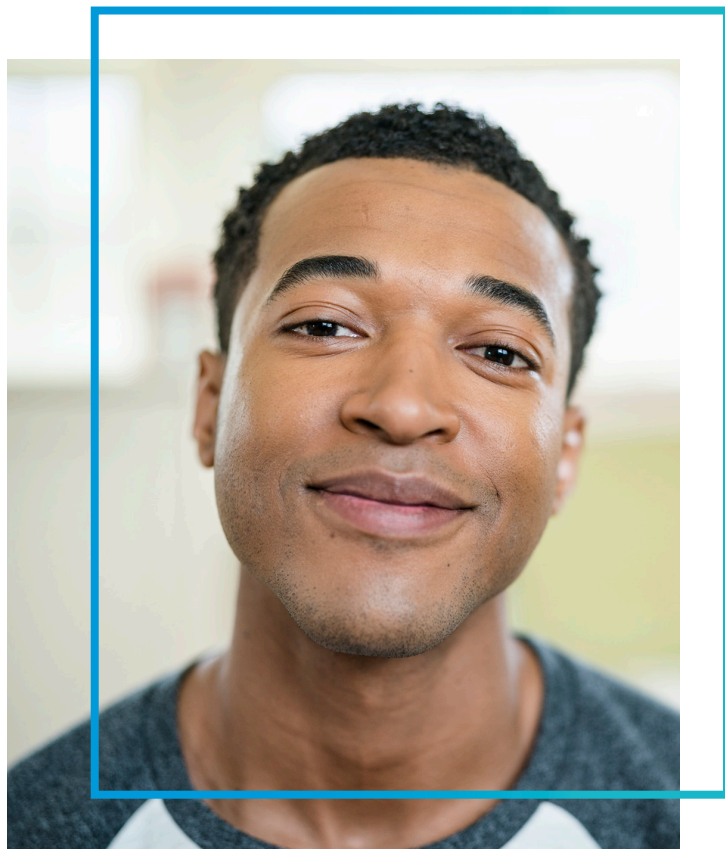
Follow-up questions can be directed to the provider within seven (7) days of the initial visit. All treatment plans will be communicated through your Message Center.

**Can I choose my doctor?**

The first time you request a visit, Teladoc will page the first available provider. On subsequent visits, you will have the option to select the same provider or the first available provider.

**Can I address more than one condition when I request a visit with a dermatologist?**

Teladoc does ask that you limit request for a visit to one medical condition.



**Are there dermatology conditions not treated by Teladoc?**

The Teladoc dermatologist will determine treatment options based on the visit.

**What can be shared with my primary care physician?**

Unless you specifically ask us to do so, we do not share your medical record. Image uploads are not available on the Teladoc portal continuity of care record, but are always available in your Teladoc medical health record.

**Can a dermatology visit be scheduled for someone under the age of 18?**

Dermatology visits are available to all Teladoc members.

**Is dermatology available in all states?**

Teladoc offers visits in states where telemedicine services and teledermatology is allowed.
